

# Community Activities Grant Guidelines 2021/22

## Introduction

This grant provides funding to community organisations to deliver self-sustainable local community, cultural, sporting and environmental activities in the Moreton Bay Region.

Projects funded under this grant will provide opportunities for people to develop and enjoy a vibrant lifestyle as part of a strong and inclusive local community.

Grant applications will be invited in July and February as outlined below.

| Eligible applicants | <p>A community organisation that applies for funding under this grant must meet the following criteria:</p> <ul style="list-style-type: none"> <li>• Be based in the Moreton Bay Region and/or can demonstrate that the proposed project will benefit residents of the region;</li> <li>• Have \$20 million public liability insurance if required by Council; and</li> <li>• Have no overdue Moreton Bay Regional Council grant acquittals.</li> </ul> <p><b>Community organisation</b> means:</p> <p>(a) an entity that carries on activities for a public purpose; or<br/>(b) another entity whose primary object is not directed at making a profit.</p> <p>The following are ineligible organisation types:</p> <ul style="list-style-type: none"> <li>• For-profit organisations;</li> <li>• Government departments and agencies;</li> <li>• Schools and affiliated parents' associations;</li> <li>• Kindergartens and childcare organisations;</li> <li>• Political groups; and,</li> <li>• Unincorporated community groups.</li> </ul> <p>Unincorporated community groups may apply through an Auspice which is able to accept legal and financial responsibility for the project. The auspice organisation must meet the above criteria and not be an ineligible organisation type.</p> <p>Individuals are not eligible to apply for funding under this grant.</p> |

| Eligible projects | <p>Projects supported must deliver self-sustainable local community, cultural, sporting and environmental activities in the Moreton Bay Region and may include activities that:</p> <ul style="list-style-type: none"> <li>• Encourage residents to get to know their neighbours;</li> <li>• Increase the use of parks, open space and natural areas by the wider community;</li> <li>• Promote participation in community life;</li> <li>• Increase the use of Council's community halls and centres by the wider community;</li> <li>• Enhance the safety of local neighbourhoods;</li> <li>• Protect, enhance and showcase the region's natural environment and biodiversity;<sup>1</sup></li> <li>• Provide opportunities for residents to participate in arts and cultural activities;</li> <li>• Encourage residents to share, develop and acquire new skills and knowledge;</li> </ul> |

|                         | <ul style="list-style-type: none"> <li>Promote volunteering for community organisations;</li> <li>Encourage residents to participate in an active and healthy lifestyle; and</li> <li>Assist residents to prepare, respond and recover from a natural disaster.</li> </ul> <p>Projects must be completed within 14 months from the round closing date.</p>  |
| Ineligible projects     | <p>Ineligible projects include:</p> <ul style="list-style-type: none"> <li>Projects that do not meet the requirements of Council's <a href="#">Community Grants Policy</a> or these guidelines;</li> <li>An activity that has a commercial purpose;</li> <li>Activities with the primary objective of fundraising;</li> <li>Christmas and New Year's Eve events;</li> <li>Activities that are exclusively for the members of the community organisation, or are considered its core business; and</li> <li>Projects that have been funded twice previously under the Community Grants Policy (2150-030).</li> </ul> |
| Ineligible expenses     | <p>Ineligible project expenses include:</p> <ul style="list-style-type: none"> <li>Operational or recurrent costs associated with the usual business of a community organisation including, but not limited to, salary/wages, insurance, utilities, rates, administration and rent;</li> <li>Gifts, alcohol, prizes (e.g. money, trophies, vouchers, etc);</li> <li>Purchase of equipment (unless directly related to the eligible project); and</li> <li>Purchase of capital items.</li> </ul>   |
| Funding amount          | <p>Up to \$10,000 (GST inclusive) is available per application.</p> <p>Where community organisations act as an Auspice for unincorporated community groups, these funds will not form part of the auspicing organisation's maximum annual funding limit.</p> <p>Retrospective funding of projects is not available.</p>   |
| Lodging an application  | <p>Applications must be submitted online via Council's grants and funding webpage <a href="http://www.mbrc.qld.gov.au/grants/">www.mbrc.qld.gov.au/grants/</a>.</p> <p>Late applications will not be considered. Failure to provide all requested application information may result in your project not being considered.</p>  |
| Assessment criteria     | <p>Eligible applications will be assessed against the following criteria:</p> <ul style="list-style-type: none"> <li>Demonstrated need for the project / activity</li> <li>Benefit to the Moreton Bay Region community</li> <li>Value for money, for Council and the Community</li> <li>Capacity of the applicant to successfully complete the project</li> </ul>   |
| Terms and Conditions    | <p>Successful applicants are required to comply with the terms and conditions associated with Council's financial support.</p>  |
| Unsuccessful applicants | <p>Unsuccessful applicants may seek feedback on their application by contacting a grants officer (see contact details below).</p>   |
