3. MEMORIALS OR CONDOLENCES

Cr Peter Flannery made special mention of his late father **Mr John Robert Flannery**, who passed away last Monday, aged 82, leaving behind five children, 20 grandchildren and 9 great-grandchildren. Cr Flannery said that his father had many early careers, such as jackaroo, barber and truck driver, until he became a theatre technician which he undertook for 25 years until he retired. Mr Flannery was an avid rugby league fan, being a proud maroons supporter during the State of Origin games. Cr Flannery said that his father will be sadly missed and thanked Council for their support during this time.

The Mayor (Cr Allan Sutherland) concurred that Mr Flannery's service yesterday was touching with many people in attendance, adding that he must have been very well respected. The Mayor asked Council to give their thoughts to their colleague and expressed condolences to Cr Flannery and his family.

Cr Julie Greer made special mention of the late **Ms Ann Ray** who had been an employee of the former Pine Rivers Shire Council, and resident of Beachmere who passed away last week, aged 71. Cr Greer said that Ms Ray commenced in the Rates department in 1983 and moved to the Works & Services department as part of her 30 years employment with the former Council. Cr Greer said that her thoughts are with the family.

Cr Adam Hain made special mention of the late **Ms Jan Dooley** of New Farm who passed last week. Cr Hain said that Ms Dooley was a community leader who was heavily involved in fundraising in the greater Brisbane region, and expressed condolences to her family.

Cr Darren Grimwade made special mention of the late **Mr Jamie Bird** who passed away last week after a fatal car accident. Cr Grimwade said that although Mr Bird resided at Bald Hills, he was formerly a long-term member of the Narangba community, being best known as the Store Manager at Narangba Woolworths. Mr Bird was big-hearted and passionate about supporting fundraising in the community and local schools and would be sadly missed.
