Petition - Dr Philip Williams and Mr Russell Noonan - Development Application 5.1. (DA/37893/2019/V2M) 233 Welsby Parade, Bongaree (A18539307, A18533260)

Cr Brooke Savige tabled two like petitions received from:

- Dr Philip Williams containing 131 signatures; and
- Mr Russell Noonan containing 69 signatures

reading as follows:

"DO NOT APPROVE the proposed development application DA/37893/2019/V2M for a 6 storey unit complex at 233 Welsby Road [sic], Bongaree, Bribie Island. Six storeys is far too high for this location on the foreshore. When you drive over the Bribie bridge towards the island, the current 3 to 4 storey unit buildings along the foreshore blend in with the tree line and are not an eyesore. The proposed building would stick up well above the tree line completely spoil the current vista. The proposed development would also generate excessive extra traffic movements in an already congested area and further exacerbate the problem of the very messy right hand turn and back street route off Welsby Parade towards Benabrow Ave."

Council received the two petitions, referring them to the Director Planning and Economic Development for investigation and report to Council, if required.

Petition - Mrs F Falvey - Development Application (DA/37893/2019/V2M) 233 Welsby Parade, 5.2. Bongaree (A18525100)

Cr Brooke Savige tabled a petition containing 265 signatures, received from Mrs F Falvey, reading as follows:

"The proposed development of 233 Welsby Parade, Bongaree Qld 4507 on Lots 25 & 26 on RP62926, is over the allowable current height of 15 meters and will take away from the natural beauty of Bribie. 3 Storeys should be the limit, including garaging/shops etc.

Bribie Island is noted for its natural beauty with the height of the buildings not exceeding the lovely tree line. The Gold Coast and Sunshine Coast, Redcliffe and other placed have been spoilt by the building of high rise. Bribie has a relaxing feel, it is an Island not a City. It is a place to escape from the concrete jungle.

High-density housing such as this will have a negative impact on an already fragile environment we should be striving to preserve the beauty of the environment, rather than exploiting it any further. Bribie Island is already congested, the infrastructure cannot support these sorts of developments. This is not what we want for Bribie Island.

We the undersigned are concerned above the above application and ask that you do not let developers spoil our island. Please maintain Bribie Island's character and charm."

"Coolgarra Ave speeding issue. The entire length of Coolgarra Avenue is rated at 50kph. Additional sticker signage by residents has been mocked and ignored. As Coolgarra Ave is constantly a thoroughfare for schoolchildren, pedestrian traffic including motorised scooters and bicycles, we request speed restrictors be installed as soon as practicable."

Council received the petition, referring it to the Director Infrastructure Planning for investigation and report to Council, if required.

5.4. Petition - Anthony Welham - Planned redevelopment 75 Redcliffe Parade, Redcliffe (A18544288)

Cr Koliana Winchester tabled a petition containing 116 signatures, received from Mr Anthony Welham, reading as follows:

"We the undersigned do hereby petition the Moreton Bay Regional Council to not approve the proposed development at 75 Redcliffe Parade. This development is to be 18 Storey containing 284 units and function centre accommodating more than 750 people.

Redcliffe by nature is that of a seaside village and council should develop a plan to limit the height of development within the CBD as well as specify the style and colour of buildings, nature of business, covered walkways and outside dining. This would result in an attractive visa with no abhorrent monstrosities and associated problems such as beach shadowing reduction in Restaurant choices, lack of parking and increase in traffic."

Council received the petition, referring it to the Director Planning and Economic Development for investigation and report to Council, if required.

5.5. Petition - Mrs Linda Ansell - Speed reduction in King Street, Clontarf to Woody Point (A18554452)

Cr Koliana Winchester tabled a petition containing 51 signatures, received from Mrs Linda Ansell, reading as follows:

"Request a reduction in speed limit from 60kms to 50kms, or traffic calming and more police presence in the area to improve public safety."
