## **NOTATION**

Fairmont Group Pty Ltd (Fairmont) have applied to the High Court of Australia for special leave to appeal the recent decision of the Queensland Court of Appeal in relation to the need for development approval to clear category X vegetation. Fairmont's application to the High Court arises from decisions by the Planning & Environment Court and the Queensland Court of Appeal in which both courts agreed with Council's position that Council's Planning Scheme can regulate the clearing of category X vegetation.

Following those court decisions, Fairmont sought to meet to discuss their current development applications as impacted by the court decisions. Council has advised Fairmont on 3 occasions (as well as a representative of the State) that Council would consider meeting with them subject to Fairmont providing information about changes to their development proposal necessitated by the court decisions. Fairmont have not provided any information. Further, in view of Fairmont's application to the High Court, a meeting would be futile until after the matters consideration by the High Court, or Fairmont withdrawing from this process.

## Petition - Ms Jodi Wood - Decline Development Application 2019 / 37805 / V2M - MCU Multiple Dwelling on 50-52 Connors Street (A18705030) & (A18696488)

Cr Denise Sims tabled two petitions, one in hard copy and one an e-petition, both received from Jodi Wood with 186 and 241 signatures respectively, reading as follows:

- 1. Decline Development Application 2019 / 37805 / V2M MCU Multiple Dwelling on 50-52 Connors Street due to non-compliance with Urban Neighbourhood Precinct Development Code, particularly
- Performance Outcome PO25: Safe access is provided for all vehicle required to access the site:
- Performance Outcome PO8: Residential buildings and structures ensure consistency with character of the area and does not result in an over development of the site:
- Performance Outcome 5: Residential buildings and structures are setback to ensure car parked vehicles do not restrict pedestrian and traffic movement and safety; and
- Unacceptable impacts to environmental values particular to mature habitat trees, koala habitat and safe wildlife movement through the urban landscape.
- 2. Rezone Connors Street from General Residential Zone Urban Neighbourhood Precinct to General Residential Zone Suburban Neighbourhood Precinct.

Council received the petition, referring it to the Director of Planning and Economic Development for investigation and report to Council, if required.
