Read first:

Have you reviewed Council's website regarding Barking Dog information?

Have you spoken with the animal owner about the issue or placed a notification letter (can be downloaded from Council's website) into the animal owners letter box?

If you decide to lodge a complaint with Council, for Council to assess if your complaint will be further investigated under the *Animal Management Local Law 2023*, we require an animal noise nuisance diary to be completed.

Your complaint cannot be progressed unless you have supplied a 7-day diary.

You must record at least **7 days of information**. The 7 days must not include days you are not at home. The diary must be completed within 4 weeks of your complaint. Failure to provide a 7-day noise nuisance diary will result in your complaint being withdrawn.

Upon completion of this document, an Authorised Officer will assess the information you have provided and establish whether a pattern of behaviour exists to substantiate an offence under the Local Law. If Council is unable to substantiate an offence, you will be informed of the decision and the matter will be closed, unless substantial new evidence that affects the decision or outcome is provided.

First/Initial Complaint – can be approximately up to 20 days



Second and subsequent substantiated complaint within 12 months
