

Photography and Media Permission Terms and Conditions 2024

I consent to sound recording and its/their release, publication, exhibition, or reproduction to be used for public relations, news articles or telecasts, education, advertising, research, inclusion on the Moreton Bay City Council website (in accordance with the terms and conditions of that website), fundraising, or any other purpose by Moreton Bay City Council and/or its affiliates. I release Moreton Bay City Council, their officers and employees, and each and all persons involved from any liability connected with the taking, recording, or publication of said interviews, photographs, slides, computer images, videotapes, or sound recordings.

I consent to any sound recording that I share or give to Council for an activity or competition that I have booked or chosen to participate in being edited for the purpose of release, publication, exhibition, or reproduction to be used for public relations, news articles or telecasts, education, advertising, research, inclusion on the Moreton Bay City Council website (in accordance with the terms and conditions of that website), fundraising, or any other purpose by Moreton Bay City Council and/or its affiliates.

I waive all rights I may have to any claims for payment or royalties in connection with any exhibition, televising, or other publication of these materials, regardless of the purpose or sponsoring of such exhibiting, broadcasting, or other publication irrespective of whether a fee for admission or film rental is charged. I also waive any right to inspect or approve any photo, video, or film taken by Moreton Bay City Council or the person or entity designated it by it.

I also waive my right to inspect or approve any edit or alteration of the sound recording that I share or give to Council for an activity or competition that I have booked or chosen to participate in.

I release and discharge Moreton Bay City Council and/or its affiliate(s) from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form whether intentional or otherwise, that may occur or be produced in the editing of any sound recording and resulting or derivative works and in any processing toward the completion of the finished product.

All sound recording and resulting or derivative works are licenced to Council for purposes related to the activity being engaged or entered into exclusively and irrevocably until the end of the competition, at which point rights revert to the Entrant.

The copyright in sound recording and resulting or derivative works remains with the Entrant, however, Council maintains the right to use sound recording and resulting or derivative works or part thereof in promotions, present and future. Council reserves the right to reproduce the sound recording and resulting or derivative works or parts thereof for the purpose of publicity, critical review or archival reference, in hard copy or digital/web formats. Entry of sound recording and resulting or derivative works constitutes the Entrant's permission for such reproduction.

I declare that I am eighteen (18) years old or older and am legally competent to execute this release or that I have acquired the consent of my parent or guardian. I understand that the terms herein are contractual and not a mere recital, that this instrument is legally binding, and that I have voluntarily submitted this document.
