Riparian Rainforest

Description:	This ecosystem occurs along creeks and riverbanks on well-drained coarse alluvium soil. Riparian rainforest ecosystems are high in biodiversity and provide important corridors for the migration of many native birds and animals. Species found include: Weeping myrtle (<i>Waterhousea floribunda</i>) - dominant, Rib-fruit Pepperberry (<i>Cryptocarya hypospodia</i>), Pepperberry tree (<i>C. obovata</i>), Brown Laurel (<i>C. triplinervis</i>), Brown Tulip Oak (<i>Argyrodendron trifoliolatum</i>), Creek sandpaper fig (<i>Ficus coronata</i>), Sandpaper fig (<i>F. fraseri</i>), Black Bean (<i>Castanospermum australe</i>) and Hoop Pine (<i>Araucaria cunninghamii</i>)
Ecological values:	This ecosystem provides habitat for numerous rare and threatened flora including Maroochy Nut (<i>Macadamia ternifolia</i>) and Queensland Nut (<i>Macadamia integrifolia</i>). Prone to invasion by Camphor Laurel (<i>Cinnamomum camphora</i>) and Cat's Claw Creeper (<i>Macfadyena unguis-cati</i>). Important habitat for fruit-eating birds, many of which migrate seasonally from upland to lowland rainforest




Figure 1: Representative areas in the MBRC where RE 12.3.1 can be found
