Part 1 Preliminary

1 Short title

This amendment Subordinate Local Law may be cited as the *Amendment Subordinate Local Law (Shopping Trolley Containment Systems) 2024*.

2 Subordinate Local Laws amended

This amendment Subordinate Local Law amends the *Community Standards for Public Land and Roads Subordinate Local Law 2023*.

3 Object

The object of this amendment Subordinate Local Law is to amend the *Community Standards for Public Land and Roads Subordinate Local Law 2023* to declare a system other than a wheel lock system to be a shopping trolley containment system.

Coin or token lock system	A system which requires a coin or token to be inserted to unlock a trolley from a trolley bay, with coins or tokens refunded when trolleys are returned.
