

PLANNING SCHEME FOR REDCLIFFE CITY

The Redcliffe City Planning Scheme 2005 first took effect on 12 December 2005.

Amendments (Adoption and Commencement)

- (1) The local government for Moreton Bay Regional Council (incorporating the former Redcliffe City Council Local Government Area) adopted the first package of amendments to this planning scheme on 8 April 2008. These amendments to the planning scheme took effect on 8 April 2008.
- (2) The local government for Moreton Bay Regional Council (incorporating the former Redcliffe City Council Local Government Area) adopted new and amended planning scheme policies on 8 Sept 2009. These amendments to the planning scheme took effect on 29 October 2009.
- (3) The State Government, by gazettal dated 25 June 2010, made changes to the Redcliffe Planning Scheme to incorporate the Scarborough Harbour in the Redcliffe Planning Scheme area. These changes included new assessment tables, definitions and other regulatory provisions required to effectively regulate development within the area. These planning provisions took effect on 25 June 2010.
- (4) The local government for Moreton Bay Regional Council adopted amendments to this planning scheme on 14 June 2011. The amendments took effect on 4 July 2011.
- (5) The local government for Moreton Bay Regional Council adopted amendments to this planning scheme on 27 September and 11 October 2011. The amendments took effect on 17 October 2011.
- (6) The local government for Moreton Bay Regional Council adopted the Redcliffe Priority Infrastructure Plan and associated amendments to this planning scheme on 28 March 2013. The amendments took effect on 8 April 2013.

1. SPP 1/02 Development in the Vicinity of Certain Airports and Aviation Facilities
