Moreton Bay City Council Amendment Local Law (Effective Control of Dogs and Other Matters) 2025

Part 1 Preliminary

1 Short title

This Amendment Local Law may be cited as the Amendment Local Law (Effective Control of Dogs and Other Matters) 2025.

2 Local Laws amended

This Amendment Local Law amends the following Local Laws (*relevant Local Laws*)—

- (a) Alteration of Public Land Local Law 2023; and
- (b) Animal Management Local Law 2023; and
- (c) Commercial Use of Public Land and Roads Local Law 2023; and
- (d) Community Standards for Public Land and Roads Local Law 2023; and
- (e) Election Signs Local Law 2019; and
- (f) Events Local Law 2023; and
- (g) Parking Local Law 2023; and
- (h) Signs Local Law 2023.

3 Object

The object of this Amendment Local Law is to—

- (a) for the Animal Management Local Law 2023—
 - (i) remove the requirements for effective control of dogs in public places to ensure consistency with the *Animal Management (Cats and Dogs) Act 2008*; and
 - (ii) allow an authorised person to seize an animal for wandering at large if another person finds the animal wandering and delivers it to a veterinary surgery; and
 - (iii)allow an authorised person to inspect an enclosure on a person's property if the person's animal has been seized for wandering at large 3 times in a 12 month period, prior to releasing the impounded animal back to the person; and
 - (iv)limit the noise nuisance defence for the keeping of a rooster to a property that is more than 20,000m²; and

- (b) allow persons who lawfully kept an animal without an approval under the *Moreton Bay Regional Council Local Law No. 2 (Animal Management) 2011* to continue to keep the animal; and
- (c) for the Community Standards for Public Land and Roads Local Law 2023—
 - (i) remove Council's power to require an owner or occupier of land adjacent to an overgrown road verge to cut and remove the vegetation on the road verge; and
 - (ii) enable the local government to make the verge garden guideline other than by resolution of the local government; and
 - (iii)enable the local government to temporarily close an area of public land to public access other than by resolution of the local government; and
 - (iv) exclude from the operation of the Local Law the local government's regulation of abandoned ships, or parts of ships, in Queensland waters; and
- (d) for the Events Local Law 2023—
 - (i) include additional public safety criteria for a small gathering; and
 - (ii) allow Council to immediately cancel an approval if the continued operation of the event poses certain threats, risks or obstructions arising from a disaster or weather event; and
- (e) make other minor and consequential amendments to the relevant Local Laws.

52 Control of animals in public places, other than dogs

- (1) The owner or responsible person for an animal that is not a dog must ensure that the animal is not in a public place—
 - (a) unless the animal is under the effective control of a person in accordance with subsection (2); and
 - (b) if the animal is a declared dangerous animal—unless the animal is securely restrained to prevent it from—
 - (i) attacking a person or animal; or
 - (ii) acting in a way that causes fear to a person or animal; or
 - (iii) causing damage to property.

Maximum penalty—20 penalty units.

- (2) For subsection (1), an animal that is not a dog is under *effective control* if—
 - (a) a person who can physically control the animal—
 - (i) is holding it by an effective leash, halter or rein; or

- (ii) has effectively tethered it to an object that cannot be moved by the animal and the animal is under the direct supervision of the person; or
- (iii) has corralled it in a temporary enclosure adequate to contain the animal and the animal is under the direct supervision of the person; or
- (b) the animal is tethered in or on a vehicle and unable to reach beyond the vehicle extremities; or
- (c) the animal is participating in, or being exhibited or trained at, an exhibition or an obedience trial supervised by a body recognised for this section by the local government.
- (3) In determining whether a person can physically control the animal in accordance with subsections (2)(a), an authorised person may consider—
 - (a) the number of animals under that person's supervision; and
 - (b) any other relevant matter the authorised person considers appropriate.
 - (4) In this section—

direct supervision means the continuous observation of an animal by a person who is in a position to immediately respond to the animal's behaviour, including where a person, who can physically control the animal, holds the animal by an effective leash.

 - (b) to protect the health and safety of a person or the security of a person's property; or

- (d) to conserve or protect the cultural or natural resources of the area or native wildlife.
